Mr. Don Salo, a member of the Senior Executive Service, serves as the Deputy Assistant Secretary of the Army for Military Personnel/Quality of Life. He provides policy supervision and oversight of military resource programs for the Army's Total Force, personnel readiness, health care, human resources system for Army families, and all Quality of Life matters.

He previously served as the Director, Defense Forensics and Biometrics Agency, an Army Field Operating Agency recognized by the *Washington Post* as a "2016 Top Workplace", and led, consolidated, and coordinated forensic and biometric activities across the DoD in support of global identity operations and the National Security Strategy.

Mr. Salo's previous joint enterprise wide assignments include: Deputy Assistant Secretary of Commerce for Export Enforcement where he was responsible for investigative and compliance activities directed primarily at enforcing National Security and foreign policy objectives focused on sensitive exports to hostile entities, terrorists, and state sponsors of terrorism; Assistant Director for the federal government's Recovery Accountability and Transparency Board where he coordinated and conducted inquiries on a national level into the fraud, waste, abuse, and mismanagement of contracts, grants, loans, and entitlements associated with the \$840 billion funded American Recovery and Reinvestment Act; and Force Protection Advisor to the U.S. Congress in the aftermath of the 9/11 terrorist attacks on our Nation.
